# **TERMS AND CONDITIONS**

  - 7. Prohibited Conduct

You agree that you will not use the Website or Services to:

- 8.2 Each party irrevocably agrees that the courts of the United Arab Emirates shall have exclusive jurisdiction to settle any dispute or claim that arises out of or in connection with these Terms and Conditions or their subject matter or formation (including non-contractual disputes or claims).

### Section 9: Miscellaneous

- 9.1 If any provision or part-provision of these Terms and Conditions is or becomes invalid, illegal or unenforceable, it shall be deemed modified to the minimum extent necessary to make it valid, legal and enforceable. If such modification is not possible, the relevant provision or part-provision shall be deemed deleted. Any modification to or deletion of a provision or part-provision under this clause shall not affect the validity and enforceability of the rest of these Terms and Conditions.
- 9.2 No failure or delay by a party to exercise any right or remedy provided under these Terms and Conditions or by law shall constitute a waiver of that or any other right or remedy, nor shall it prevent or restrict the further exercise of that or any other right or remedy. No single or partial exercise of such right or remedy shall prevent or restrict the further exercise of that or any other right or remedy.

- 9.3 These Terms and Conditions and any documents referred to in them constitute the entire agreement between the parties and supersede and extinguish all previous agreements, promises, assurances, warranties, representations and understandings between them, whether written or oral, relating to its subject matter.
- 9.4 Each party acknowledges that in entering into these Terms and Conditions it does not rely on any statement, representation, assurance or warranty (whether made innocently or negligently) that is not set out in these Terms and Conditions or any document expressly referred to in them.
- 9.5 These Terms and Conditions do not create any agency, partnership or joint venture relationship, and shall not be deemed to create any such relationship between the parties.
- 9.6 These Terms and Conditions are personal to the Customer and the Customer shall not assign or transfer any of its rights or obligations under these Terms and Conditions without the prior written consent of RMDC International FZ LLE.
- 9.7 The Customer agrees that RMDC International FZ LLE may assign or transfer any of its rights or obligations under these Terms and Conditions to any third party.
